1 (aa) is, or on the relevant date, 2 was, an employee, independent con-3 tractor, or agent of an entity or serv-4 ice that disseminates news or informa-5 tion by means of newspaper; nonfic-6 tion book; wire service; news agency; 7 news website, mobile application or 8 other news or information service 9 (whether distributed digitally or other-10 wise); news program; magazine or 11 other periodical, whether in print, 12 electronic, or other format; or through 13 television or radio broadcast, multi-14 channel video programming dis-15 tributor (as such term is defined in 16 section 602(13) of the Communica-17 U.S.C. tions Act of 1934(47)18 522(13)), or motion picture for public 19 showing; 20 (bb) with the primary intent to 21 investigate events and procure mate-22 rial in order to disseminate to the 23 public news or information concerning 24 local, national, or international events 25 or other matters of public interest, en-

24	(B) JUDICIAL DISCRETION.—In the case of
25	a person that does not fit within the definition

of "covered journalist" described in subclause 1 2 (I) or (II) of paragraph (A)(i), a judge of the 3 United States may exercise discretion to avail 4 the person of the protections of this Act if, 5 based on specific facts contained in the record, 6 the judge determines that such protections 7 would be in the interest of justice and necessary 8 to protect lawful and legitimate news-gathering 9 activities under the specific circumstances of 10 the case.
